 - Discussion around current Mission, Vision and Values:



- i. Board and Staff decisions should support
- ii. Attendees discussed whether current DMCS Mission Statement is adequate; several modifications were proposed. Students should be at the center of the Mission Statement. Mission should reflect these key elements: Self-Motivation, Independence, Respect, Parent responsibility in education & Project Based Learning (PBL).
- iii. Discussed current school Values and methods to gather input from stakeholders. A survey was proposed to gather input on whether proposed Mission Statement and Values reflect expectations of parents. Action: develop set of questions to survey parents.
- iv. The Vision should use the current academic standards as only a base and that the school should use available tools (such as Montessori) as a means to exceed these baseline targets. State created standards as a floor, ideally students should exceed these.
- v. Suggestions on establishing strong parent, student, education relationship:
 - 1. Offer targeted courses to parents (math, language fundamentals, etc.)
- vi. Discussed length or current Vision, and proposed potential changes.
- Re-chartering discussion:
 - i. Team will be led by Joanne Green (Director)
 - ii. We will not be handing over responsibilities to district; Relationships will be contractual.
 - iii. KIPP may be a valuable resource
